

# End-User License Agreement ("Agreement")

Last updated: June 28, 2020

Please read this End-User License Agreement ("Agreement") carefully before clicking the "I Agree" button, downloading or using Ultimate JV Giveaway Script ("Application").

By clicking the "I Agree" button, downloading or using the Application, you are agreeing to be bound by the terms and conditions of this Agreement.

This Agreement is a legal agreement between you (either an individual or a single entity) and Ultimate JV Giveaway Script and it governs your use of the Application made available to you by Ultimate JV Giveaway Script.

## License

- modify, make derivative works of, disassemble, decrypt, reverse compile or reverse engineer any part of the Application.
- remove, alter or obscure any proprietary notice (including any notice of copyright or trademark) of Ultimate JV Giveaway Script or its affiliates, partners, suppliers or the licensors of the Application.

## Co-Host Restrictions

- You are allowed to have a MAXIMUM of 5 Co-Hosts Per Event. A Co-Host is defined as anyone that has access to or receives the names and/or email addresses of the giveaway event.
